

When to seek help?

Most owners know when their animal shows signs of pain or distress; as a guide, treatment should be considered if the following signs are observed.

In Horses

- Asymmetry, stiffness on one rein, disunited canter
- Unlevelness, uneven, irregular action
- Sore, cold backs
- Unexplained resistances, bucking, refusing, rearing
- Uncharacteristic changes in behaviour, temperament or performance
- Changes in muscle development



- Sudden dislike to being stroked along their backs
- Difficulty in climbing up and down the stairs, in and out of the car
- Stiffness or discomfort when getting up from their beds
- Reluctance to go for walks
- Unexplained reduced athletic performance



What does a McTimoney Treatment involve?

- Firstly a detailed history is taken
- Then a visual assessment is carried out while at rest and in walk and trot. This can include tight circles and or lunging.
 Starting at the head, and working down the back to the pelvis, the joints are palpated to check for alignment and surrounding muscle spasm
- The misaligned joints are adjusted using rapid and precise movements of the hands
- Most animals readily accept the treatment
- After treatment a detailed specific aftercare programme will be discussed, this may include a period of rest, limited exercise or specific schooling exercises and stretching exercises
